Guidelines of National Formosa University Swimming Pool Management and Usage

Latest Approved on Dec. 4, 2018, by the Administrative Meeting

- 1. The regulations for the use of NFU's swimming pool are to promote swimming and maintain the facilities.
- 2. The swimming pool is available for use for physical education classes, swimming competitions, team training, and swimming classes. Other than the mentioned schedule, the swimming pool is public.
- A certificate or ticket is required for entry to the swimming pool during its open hours.
- 4. Those who enter the swimming pool must comply with the regulations and follow the instructions of the pool staff.
- 5. From April to November, the swimming pool is open for 2 to 4 hours after school, except during holidays, exams, cleaning days, or bad weather. Please see the attachment for fees for the pool entrance.
- If other organizations plan to reserve the swimming pool, applications should be submitted to the Office of Physical Education in accordance with National Formosa University's Venues and Equipment Regulations.
- 7. The Office of Physical Education is in charge of the swimming pool. The pool is staffed with managers and lifeguards who are responsible for managing and ensuring the safety of users during class and opening hours.
- 8. Usage Regulations:

(1) Swimmers must present a swimming certificate, ticket, or card issued by NFU or be led by instructors to enter the pool.

(2) Individuals with any of the following conditions are not allowed to enter the pool: having obvious diseases such as eye conditions, heart disease, infectious diseases (skin diseases, athlete's foot, etc.), and other serious illnesses. (3) Swimmers should follow these guidelines when entering the pool:

1. Warm up before entering the pool.

2. Take a shower and wash the soles of your feet in the foot bath before entering the pool.

3. Do not apply sunscreen.

4. Wear a swim cap when entering the pool.

(4) Spitting or urinating in the pool is prohibited to maintain pool water cleanliness.

(5) Cleaning by using soap or any detergent in the pool is prohibited.

(6) Any behavior that interferes with others' swimming, such as shouting, chasing,

running around, or diving randomly, is prohibited in and around the swimming pool to maintain order.

(7) Children under 140 cm in height must be accompanied by a guardian to enter the pool.

(8) All equipment in the swimming pool should be well-maintained. If there is any damage, it must be repaired and compensated for.

(9) The staff and lifeguards are responsible for all management during the swimming pool's opening hours. If there is any activity that has a negative impact on health or safety, they should stop the activity at any time.

(10) Unauthorized entry into the swimming pool outside of its opening hours is strictly prohibited to prevent accidents. Violators will be reported to the police.

9. These regulations were approved by the Administrative Meeting and will be implemented after being approved. Any future revisions will also be approved.
